PREVENTIVE MAINTENANCE

Before you use your equipment make sure it is in good condition. Check the general condition of the equipment, as described in "Safety Information". If the equipment is not in perfect condition, contact an Authorized Technical Assistant.

CLEANING:

- Never use abrasive or solvents for cleaning.
- Do not leave the equipment exposed to natural agents such as sunlight, rain, dew, dust, salt spray etc.
- Do not put the equipment in dusty environments, wet, saunas or anywhere unventilated.
 - Always use original spare parts. Improper maintenance can cause damage to the
- product and loss of warranty.
 If you prefer, this cleaning can be done by a Technical Assistant (see values).

General Warranty Conditions

A. The warranty service will only be provided on presentation of the original invoice or receipt and within the limits set out in this term. The warranty will be provided by the Authorized Technical Assistance Network, which covers the main cities in the country. To activate the warranty, the customer must contact the authorized Athletic distributor in their country directly. B. The conditions set out in this contract are guaranteed to the first purchaser and user of this product, in accordance with legal and contractual provisions. The customer should consult the Athletic distributor in the country of purchase for detailed information on warranty coverage and service. C. The warranty will be valid from the date of issue of the invoice or sales receipt, as directed by the Athletic distributor in your country. D. Parts repaired or exchanged under this warranty do not interrupt or extend the warranty period originally stipulated. The warranty period will continue to run from the date of issue of the invoice or sales receipt. E. To benefit from this warranty, the equipment must have been installed by an authorized technical assistant, except for products for residential use only, which can be installed by the user themselves, according to the manufacturer's instructions. F. The warranty does not cover installation services or preventive maintenance, such as cleaning, lubricating and adjusting the product. These services are the responsibility of the user and must be carried out in accordance with the manufacturer's recommendations. G. No reseller is authorized to receive a product from the customer in order to send it to the Authorized Service Department, nor to remove the product from the service department for return to the customer. Furthermore, dealers may not provide information on the progress of the service on behalf of the Manufacturer/Distributor. The Manufacturer/Distributor shall not be liable for any damage or delay that occurs due to this breach of the established rules H. The Manufacturer/Distributor undertakes to keep spare parts available for product maintenance as long as it continues to manufacture or import the equipment. In the event that production or importation of the equipment is discontinued, the Manufacturer/Distributor undertakes to maintain the supply of spare parts for 5 years, to ensure the continued maintenance of the product.

Extinction of Warranty:

This warranty shall be deemed void when: A. Its normal validity period has expired. B. The equipment has been delivered for repair by persons not authorized by the Manufacturer/Distributor, or if there are signs of violation of its original characteristics, or when there is improper assembly, outside the factory standards. C. Damage resulting from misuse, use of unsuitable cleaning products, oxidation from external agents (such as humidity or prolonged exposure to the open air), negligence, unauthorized modifications, use of non- recommended accessories, falls, punctures, use and installation not in accordance with the instruction manual, electrical wiring with unsuitable voltages, lack of grounding in networks of unsuitable size and/or excessive fluctuations and overloads. D. For the residential line, any type of maintenance carried out by the user or by unauthorized third parties, other than those from the authorized technical assistance network, is prohibited. E. The product has been used in gyms, condominiums, clinics, clubs, saunas, submerged in water, or in any way other than the intended use of the product, or in conditions that go beyond the intended use of the equipment, as specified in the product manual. Observations: A. Cables, carabiners, pedals and other components that come with the product must be replaced annually to ensure the safety and proper functioning the equipment. B. of Manufacturer/Distributor shall not be held liable for any accidents and their consequences if the equipment is not in conformity with its original characteristics or if it is assembled outside the factory standard. C. Liability for incorrect use of the equipment, and the costs of unfounded calls (when the service department is called improperly or without justified cause), will be the responsibility of the customer, and the corresponding costs will be charged. **Note:** The Manufacturer/Distributor reserves the right to make changes to the product or warranty conditions without prior notice in order to improve product quality or meet new legal and market requirements.
